THE OTHER CUT AREAS ARE ONLY WALKWAYS, NOT TO BE USED FOR TAXIING AS THIS CAUSES A SAFETY HAZARD, SO COMPLY WITH OUR RULES.

Monthly Membership Meeting Minutes 7/3/2021

The meeting was called to order by President Werner Keil at 9:00 AM with 10 members in attendance. The low attendance was due to poor weather conditions.

Joe Barzyz led the Pledge of Allegiance and asked for a minute of silence for our deceased troops and friends.

A motion was made by Joe Barzyz to accept the 4/12/2021 meeting minutes, seconded by Mike Dawson. The minutes were accepted.

The Treasurers Report given by Mike Sperato was accepted as read.

Old Business:

The approximate 400 foot flying altitude was discussed again due to the possible occurence of someone flying in close proximity of a manned aircraft. After some discussion it was considered that the incident didn't occur. AMA has suggested we land whenever a manned aircraft is in your air space.

The act of flying on both runways at one time occured recently. President Werner Keil suggusted we use the arrow indicator showing which runway is active. We are neglecting to ask for a change of runways prior to takeoff. In the best interest of safety, observe and ask before changing runways.

New Business:

A motion was made by Joe Barzyz and seconded by Roger Cherry to have the Trust Test Certificate and FAA UAS Certificate of Registration become part of our Field Rules. This motion passed.

President Werner Keil reminded the members to post their USA Cerificate Number on all aircraft.

Considering the virus and the hurricane season a motion was made by Roger Cherry and seconded by Gordon McLean to postpone Membership Day until April or May of 2022. The motion passed.

We received a request to allow powerless sailplanes to launch from a winch on our site. It was considered that the winch toe line could interfere with our powered aircraft when in flight. In addition, the altitude of the launched sailplane gliding above 400 feet could jeopardize our relationship with AMA. A motion was made by Joe Barzyz and seconded by Mike Sperato denying this request. The motion was passed.

Mike Diesu reported on the FAA requirement to take the TRUST TEST. The meeting minutes were prepared by Mike Diesu and emailed to the Newsletter Editor.

As of this time I have received no confirmation regarding FAA Laws pertaining to 400 to 700 foot altitude, Remote ID or Fixed Flying Sites. AMA continues to work with FAA attempting to make these laws reasonable for all model aircraft hobbyists.

The TRUST TEST is now an FAA requirement for all Radio Control Pilots. However, failure to take the test will not prevent an AMA Membership renewal in 2022. There are a number of ways to take the TRUST TEST on your computer. I've listed one for your convenience.

- 1. Go to Chrome
- 2. Type in: modelaircraft.org/trust-google trust
- 3. Click on: Trust The Recreational USA Safety Test
- 4. Click on: Take the Test
- 5. Scroll to Start
- 6. Read the safety rules and click next
- 7. Continue to click next to take the test

At the completion of the test you will be issued a certificate the size of a credit card. You will never have to take the test again unless you lose your certificate. The certificate should be kept in your flight box.

* FAA : Some recreational fliers might have FAA registrations that expire soon. You are now eligible to renew your registration within 180 days of your expiration date. To renew your registration, visit **FAADroneZone.faa.gov**. Your registration is good for three years and costs \$5. Please be aware of scam sites regarding FAA Registration. 
