Leader Member Minute

Each month I condense the report from Scott Anderson, AMA Leader Member Minute coordinator, and post it in our Newsletter for the membership to read. This month I elected to post Scott's report in it's entirety.

Leader Member Minute Report

January 2020

First, many members are trying to renew their FAA registration. It's important to remind members that the FAA extended everyone's registration through 2020 at no cost. There is no need to renew. In addition, some members are falling victim to bogus FAA registration sites. Please remember to use the official website for registration, faadronezone.faa.gov. The registration fee is only \$5. Many have seen through social media, RC forums, AMA emails, and the news media that the FAA released its proposed rule on remote identification (remote ID). A lot of the information on social media and other sites is misinformation. AMA is still reviewing the document, but please refer to these Q&As for any questions that might come up. This is not a final rule, and we will likely ask our members to help us shape the ultimate regulation by participating and providing comments and feedback to the FAA.

Q: What is the email that the FAA sent out about remote ID?

A: In 2016, the FAA announced plans to remotely track unmanned aircraft. On December 26, 2019, the FAA published its proposed rule on remote identification in the Federal Register. This is a proposed rule, not a final rule. Please continue to monitor AMA communication because we will likely encourage members to participate in the rulemaking process to comment and shape the final rule.

O: What does this proposed rule say for recreational fliers and AMA members?

A: As we review the 319-page document, the initial read appears to show that AMA remains successful in advocating that our members will not require onboard equipage when at a flying field or approved location. The FAA gives flexibility for recognized community-based organizations (CBOs).

Q: What is AMA's stance on remote ID?

A: AMA has long advocated for a common sense approach to remote ID. Because our operations do not pose any new risk to the airspace, the burden of remote ID should apply to unmanned aircraft capable of navigating beyond visual line of sight of the operator or spotter, or operations outside of our safety programming. Some AMA proposals would allow recreational operators to meet the safety and security objectives of the rule without onboard equipage, by operating at fixed flying sites or by using a software-based app.

O: Has AMA had any say in the remote ID rulemaking?

A: AMA has been advocating on behalf of our members from the beginning on remote ID, including as a voting member on the 2017 Remote ID Aviation Rulemaking Committee. AMA continues to serve on FAA advisory committees and safety teams addressing remote ID.

Q: I heard AMA mention fixed flying sites. What about members who are not flying at a fixed site?

A: For members not at a flying field, it's unknown if they can use a ground-based solution, such as an app, to satisfy remote ID without onboard equipage. We will share more as we read and review the 319-page proposed rule.

Q: Where can I read the proposed rule?

A: You can read the entire proposed rule and FAA's announcement at www.faa.gov/news/updates/?newsId=89404.

Q: What happens next?

A: AMA will continue to shape the rule before it is finalized, including asking members to participate in the rulemaking process. Please monitor AMA communications for more information. In March 2020, the FAA will begin reviewing comments and feedback to shape the final rule. This process could take days or years.

This is not the end of RC model aviation and AMA is working hard for all AMA members. Feel free to contact me or contact the AMA Government Affairs team at AMA Headquarters with any questions.

Fly the way we always have until rules are implemented. In the mean time pay attention to the AMA gov emails, podcasts and blog. Scott Anderson

Many of the imposed rules have not been resolved. As your Leader Member I will watch for all AMA gov emails, podcasts and blogs and keep the membership informed.

The small private airport located on route 52 does not have a control tower and is not considered a fixed air space. The 400 foot altitude restriction is not a problem and an Air Traffic Letter is not required. However, while in the air we should respect those pilots using that small private airport.
