## Bay City Flyers General Membership Meeting 8 Mar 2025

0900 President Houck called the meeting to order with 14 members present. He then led the meeting with the Pledge of allegiance and a moment of silence.

Treasurer Sperato gave the financial status of the club.

Jim Slaughter made a motion to accept the minutes of the last meeting. Bruce Horvath seconded the motion.

The facia boards on the N/S shelter have been partially replaced. It should be completed by the next work day event (Mar 22).

Club member Don Mriscin donated a few planes and hobby supplies to donate to future members.

The Board of Directors recommended using the gravel that we have on hand for use on the center shelter flooring.

The majority of members present approved the recommendation.

Proposal was made to purchase a 100' x 12' metal shelter. It will be delivered and installed for approx. \$9,500.00. Maximum expense will be \$12,000.00.

Greg Baggerly made a motion to approve the purchase of the shelter. Bruce Horvath seconded the motion.

The vote was unanimous in favor of the purchase.

It was reemphasized that if a fire extinguisher was used for personal use, it MUST be replaced by the member using it.

Larry Utt made a motion to adjourn the meeting. Bruce Horvath seconded the motion.

0925 Pres. Houck adjourned the meeting.

Minutes recorded by: George Andruss V.P. BCF On Saturday, 22 March during the scheduled work day the 13 attendees present gathered for an impromptu meeting to discuss the feedback from the decision to move forward with the East/West shelter replacement with a steel structure. The feedback centered around the fact that the steel structures support poles would be spaced 5' apart causing obstruction for aircraft with wingspan's of over 60", as well as the fact that it would not aesthetically match the current structure and would be a regrettable purchase. President Houck presented an alternative bid from the Florida Pole Barn Co. which uses traditional wood building methods with 6" x 6" wood poles allowing a 12' on center spacing while retaining a wind rating of 140 MPH. The cost of this quote from Florida Pole Barn is \$13,789.00 installed. After a short discussion President Houck advised that both companies had advised him that the prices quoted would be increasing by the end of March by 5-10% due to cost increases in steel and lumber.

As a result of this information, an "Emergency" meeting was called to order to amend the vote from the Club Meeting of 8 March to proceed with the purchase of the Florida Pole Barn quote as presented. A motion was made by Cliff Wilder and seconded by Jim Slaughter, the motion was unanimously approved.

Motion to adjourn made by Roger Cherry and seconded by Mike Kohanyi.
