President's Note

July 2025

If you haven't been to the Field in the past month, the new shelter has been installed! We are grateful to all those who contributed to the "rebuild/repair" fund as we were able make this purchase without touching any regular yearly Club income funds. We are now ready to continue forward with the purchase of the floor pavers as we installed in the current shelter. As stated in previous communications to the Club, costs have increased significantly for materials, and we had suggested an additional donation of \$50 per Club Member to assist with the increase to ensure we do not deplete regular Club funds for these repair expenses. To date, we have seen approximately 25-30 Members step-up and make this additional donation. While this is certainly not mandatory, we are encouraging those who have not made this additional \$50 donation to use the link on the website, and provided below, to assist in covering the rest of the expenses with the setup of the new replacement shelter (ie., floor and electrical outlets and fans).

An email was received approximately two weeks ago from our SWFWMD representative to advise that 10 more hogs were removed from the property, mostly near our runway areas. This coincides with the last damage repairs that were made to the Field and we have not seen any damage since. I have conveyed a huge "Thank You" to our representative and the trapper who has done an outstanding job this season.

The next Club meeting will take place on 12 July, 2025 @ 0900. This is one week later than normal as there are several Members who will be out of town for the July 4th holiday weekend.
